

TERMS & CONDITIONS:-

This permanent Recognition is granted that on the subject to the condition that the documents/information furnished by the school authorities are factual and not devoid of truth in any way, however, if any information at any stage, is found contrary to the facts the recognition would be revoked forthwith

The school shall follow the course of study as per syllabus prescribed by the affiliated board.

The school shall charge fices and funds as declared to the appropriateauthority at the time of application for recognition and display the same on the notice board of the school and shall not increase the fees during the any academic session. In case of any change in the fee structure the school shall inform to the appropriate authority in the month of Japuary for the next academic year and will also issue printed

Salary shall be paid as per declaration at the time of seeking recognition.

No capitation fee and other charges shall be charged from the children/parents.

School shall be open for admittion without any discrimination based on religion, caste, race, place of birtho any other whimsical.

Managing Committee shall not allow to run two schools affiliated by different board/council in the same premises.

Managing Committee shall not close down the sphool or and existing class during the academic session without the prior approval of the appropriate authority.

The school shall be open.

The school shall be open for inspection for the inspecting officer authorized by the Director/Appropriate Authority.

10. Recognition so granted shall be reviewed after every 10 years.

11. No financial assistance shall be granted by the Department to the school.

School premises shall not be used for commercial purpose and anti National activities.

Approval of Managing Committee shall be obtained from the appropriate authority in case of any change in the committee.

- 14. The Managing Committee shall follow the instructions issued by Government/Director from time to time and supply the information to the Govt/Department as required.
- 15. In addition to above the Managing Committee shall abide by the provisions of Haryana School Education Rules, 2003 and amendments if any thereafter. The Managing Committee shall be liable for disciplinary action in case of violation of any provisions of the rules.

School will provide ramp within six months otherwiserecognition will stands withdrawn.

17. If any information, at any stage found Contrary to the Fact's the recognition would be revoked forthwith.

18. That the number of students in classroom shall not be more than the students calculated on the 10 square feet per student for secondary and Senior Secondary Schools and 9 Square feet per student fo elementary state.

19. The managing committee shall abide by the provisions of Haryana School Education Rules 2003 (amended) & R.T.E. Rules 2011 and ammedments it any thereafter. The Managing shall be liable for diciplinary action in case of violation of any provision of the rules.

Subject :- Recognition Certificate for the School under sub-rule (4) of rule 12 of Haryana State Right of Children to Free and Compulsory Education Rules, 2011 for the purpose of Section 18 of Right of Children to Free and Compulsory Education Act, 2009.

Dear Sir/Madam.

With reference to your application dated 30-11-13 and subsequent correspondence with the school/inspection in this regard, I convey the grant for provisional recognition to Shemford School, Barara (Ambala) for Class 1st to 8th to with effect from 01-04-2014 run by Managing Committee, Overseas Educational & Welfare Society, Barara (Ambala)

The above sanction is subject to fulfillment of following conditions:-

- I. The grant for recognition is Class not extendable and does not in any way imply any obligation to recognize/affiliate beyond Class VIII.
- The school shall by the provisions of Right of Children to Free and Compulsory Education Act, 2009 and the Haryana State Right of Children to Free and Compulsory Education Rules 2011.
- 3. The school shall admit in class I, to the extent of the Strength of that class. Children belonging to weaker section and disadvantaged group in the neighborhood and provide free and compulsory elementary education

Provided, that in case of pre primary classes also, this norm shall be followed.

4. For the children referred to in paragraph 3, the school shall be reimbursed as per sub section (2) of section 12. To receive such reimbursements school shall provide a separate bank account.

5. The school shall not collect any capitation fee and subject the child or his or her parents or guardians to any

6. The school shall not deny admission to any child for lack of age proof. If such admission is sought subsequent to the extended period specified for admission, the same shall not be denied and the shall not be densed and the child shall not be discriminated on the ground of religion, caste or race, place of birth or any

The school shall ensure that :-

- (i) no child admitted shall be held back in any class or expelled from school till the completion of elementary education in a school;
- (ii) no child shall be subjected to physical punishment or mental harassment;
- no child is required to pass any board examination till the completion of elementary education.
- (w) every child completing elementary education shall be awarded a certificate as laid down under
- inclusion of students with disabilities /special needs as per provision of the Act;
- (vs) the teachers are recruited with minimum qualifications as laid under section 23(1) of the Act. Provided further that the current teachers who, at the commencement of this Act do not posses minimum qualifications shall acquire such minimum qualification within a period of 5
- (vii) the teacher performs its duties specified under section 24(1) of the Act; and
- the teachers shall not engage himself or herself for private teaching activities.
- 7. The school shall follow the syllabus on the basis of curriculum laid down by academic authority.
- 8. The school shall enroll students proportionate to the facilities available in the school as prescribed 19. 9. The school shall maintain the standards and norms of the school as specified in section 19 of the Act. The facilities reported at the time of last inspection are as given under :-
